#### **Latest News**

An official second draft of the Procurement Bill has now been published and can be accessed here. This version has many updates from the first draft published on 11th May 2022, gaining these changes as it moved through itÕs 1st, 2nd and Committee stages in the House of Lords. The next stage for the Procurement Bill is the Report Stage, where any member of the Lords can take part in the detailed examination, and vote on any amendments.

Day 7 of the Committee Stage (26th October) saw 119 amendments agreed which shows just how busy the passage of the Bill through the House of Lords is, and the degree to which it is being scrutinised.

In more than four hours of debate, the Lords discussed a

wide variety of aspects, including the proposals to require KPIs for the delivery of contracts, something that the PCR 2015 is silent on. The Lords debate on the benefits of KPIs included comments such as Ôwhat gets measured gets managedÕ and ÔwhatÕs monitored gets doneÕ.

The ebbs and flows of the wording of the Procurement Bill will hopefully stop at a place where the balance between the benefits for buyers and suppliers is fair.

Day 6 of the Committee Stage (24th October) of the Procurement Bill, included the proposal for a new exclusion ground where the Lords stated OWe are taking action in the Bill to introduce a new around for exclusion. specifically to address situations where a supplier poses a threat to national security. The new exclusion ground allows a contracting authority to reject bids from suppliers that the authority considers pose a threat to the national security of the United Kingdom.Ó With the elevated levels of uncertainty in the world this proposal (if passed) may take on great significance.
